Hospitals interested in participating in the Hospital Transformation Program (HTP) must engage organizations that serve and represent the broad interests of the community, including clinical providers, to identify community needs and resources to inform their applications to the HTP. Hospitals should utilize existing forums and collaborations already in place, such as health alliances, when possible, rather than establishing new forums of engagement.

- Existing forums and collaborations already in place will be leveraged as reasonably feasible and the hospital has obtained letters from coalition and meeting coordinators expressing that they are aware of the Action Plan and that they intend to participate in the CHNE process (hospitals will be expected to reach out to the Department to seek assistance if they experience difficulties in leveraging existing coalitions and meetings);



- A diverse enough range of venues, locations, times and manners for engagement will be provided to ensure a meaningful opportunity for participation;
- Opportunities for engagement will be held at regular intervals;
- The venues for engagement will provide opportunities for information to be shared out and input to be received;
- There is a plan for providing adequate notice of engagement opportunities and for providing updates; and
- The program participants have identified or have a process planned for identifying existing Community Health Needs Engagement or other data to complete an evidence-based environmental scan, including identifying community needs and existing resources and gaps.

Action Plans must be submitted in .pdf form with all supporting documentation via e-mail by November 30, 2018 at 5pm to the CO HTP email address COHTP@state.co.us. Plans received after this deadline will not be considered and hospitals will be expected to begin implementing their plans immediately following submission, or earlier.

Following the submission date, the State will review the Action Plans. The plans will not be scored. However, the State will work collaboratively with participants in December 2018 to refine plans as needed to reflect a CHNE process with which both the participant and the State are comfortable.

UCHealth Grandview Hospital will collaborate with UCHealth facilities and other health care organizations and hospitals in close geographic proximity in order to assure ease of interaction with community stakeholders in conducting an environmental scan and community health needs engagement process.

UCHealth Grandview Hospital will work closely with El Paso County Public Health (EPCPH), an experienced convener of community organizations in the El Paso community. The EPCPH already convenes the Healthy Community Collaborative (HCC) on a quarterly basis with over 60 community organizations. The purpose of the HCC is to work together to implement activities and proven strategies within partner agencies to improve the health of the people of El Paso County. In addition, EPCPH has a desire to work closely with health care systems to: 1. Share findings of 2017 community health needs assessment and 2. Help health care systems connect with a broad set of community organizations. The goal is to collectively improve upon the publicly available thriving Colorado dashboard metrics.

EPCH will convene a group of clinical stakeholders including, but not limited to, health care systems, federally qualified health centers, community mental health centers, and regional accountable entities to conduct a joint HTP environmental scan. We will leverage the ongoing HCC meetings to discuss findings related to the environmental scan with larger representation from community organizations to share findings and obtain feedback from our community organizations.

One of the goals of the community health needs engagement process is to determine what larger community based committees and meetings exist where hospitals can play a key role and utilize current data/findings that are already in existence. Currently, UCHealth Grandview Hospital also participates in the El Paso Behavioral Health Consortium. We hope to partner with those larger stakeholder advisory and community groups in order to incorporate current findings related to care gaps found in mental health and substance use disorders.

In parallel to the EPCPH meetings, UCHealth Grandview Hospital has identified the following key health care partners to conduct smaller operational working group meetings in order to identify current care gaps related to care transitions practices for Medicaid clients utilizing UCHealth Grandview Hospital:

- Peak Vista: the major Medicaid primary care provider for the region and local FQHC, providing integrated behavioral health care, dental and specialty care.



- Aspen Pointe: the local community mental health center of the area, providing both mental health and substance use disorder for Medicaid clients in this region.
- Colorado Community Health Alliance: As the regional accountable entity of this area, we are partnering with CCHA to have stronger partnerships that can help us address challenges related to caring for Medicaid clients. We will further collaborate on P4P metrics and in aligning efforts whenever possible.

At this time we have found gaps in collaborating with all ten community organizations listed in the action plan template. However, we have engaged with our Regional Health Connector, RAE and Public Health Agency, in order to identify our all state mandated partnership agencies.

In creating UHealth Grandview Hospital's action plan, we met with each one of the aforementioned community organizations, in person or by phone, to disseminate information related to the hospital transformation program and educate our community partners about the goals of this new hospital Medicaid value based program. We also discussed the development of this action plan in collaboration with the aforementioned community organizations.

Moving forward, the ECPH will convene key clinical community organizations from various backgrounds to discuss the environmental scan activity and align datasets/goals from other agencies as it pertains to the five hospital transformation priority areas. A product of the ECPH HTP meetings, will be to describe recommendations to the RAE on common data elements that hospitals, clinic partners and LPHAs require, in order to fully understand care gaps under the five HTP priority areas. On a quarterly basis, hospital representatives will present HTP related information at the HCC for further discussion to gain broader community organization feedback. Meeting invitations will occur via email.

UHealth Grandview Hospital will leverage the Regional Accountable Entity existing community forums, namely the Program Improvement Advisory Committee (PIAC) and the provider network meetings to communicate HTP findings, receive feedback from community organizations, and engage in further needed partnership.

Updates from ECPH will be shared with UHealth, HCC members and any other necessary community partners through meeting minutes or other meeting summaries. The mid-point report will describe findings from the community health needs assessment and will be publicly available on HCPF's website.

EPCPH strives to be the leader in data tracking, monitoring and analysis from national and local sources and will convene data from a series of stakeholders through the HCC for this process, including the regional accountable entity and hospitals. Existing resources such as the 2017 El Paso County Health Indicators Report and the 2017-2021 Community Health Improvement Plan will be used. Other data sources that plan to be used are from the Colorado Department of Public Health and Environment, Behavioral Risk Factor Surveillance System, the Healthy Kids Colorado Survey, and local hospital and emergency department data. Sharing data related to hospital systems has previously been a gap for EPCPH, as they do not have an interconnected system to allow us access to local hospital-related data.

UCHealth System is developing an internal data workgroup with the purpose of aggregating, evaluating, and making recommendations on the current HTP population needs. Recommendations from the data workgroup will be given to hospital-community stakeholder groups to help facilitate conversations and convey population health needs in an objective manner. The internal data workgroup meeting will occur on a monthly basis, and will be attended by representatives of the population health department, revenue cycle department, care management and social work department, data-analytics, and include physician-medical provider participation. UCHealth will work closely with EPCPH in sharing summarized findings of the UCHealth system internal data workgroup.

Summary of findings will be presented at the local community meetings organized by EPCPH and CCHA. These meetings will be publically announced.

We would like to leverage ongoing partnership meetings to avoid community meeting fatigue. As we meet with larger convener groups and stakeholders, we may change our meeting infrastructure and scheduling to reflect feedback received from the community organizations. We understand that despite our best efforts to engage with community organization partners, we may have missed key community organizations that we should meet and discuss future partnership opportunities. We hope to utilize the RAE, state, LPHA, and RHC as a means to disseminate findings related to hospital work and determine future additional partnerships, as they relate to the HTP CHNE and/or HTP program development phase.



In depth data aggregation, exchange and analysis are quite time consuming and the CHNE timeline may not accommodate for such activities to take place in a way that will appease all stakeholders. We will work closely with our stakeholders, legal department, and data departments to understand and report on limitations associated with conducting such activities. We may have gaps in data sources and data types (database, interviews, survey results, etc), specifically it may be challenging to find forums that coordinate meetings with Medicaid citizens, therefore their perspective may not be identified. We would like to work closely with the state and advocacy groups that can help UCHealth identify such opportunities.

The HCC is a stakeholder group of community partners who have been working together since 2011 to implement strategies identified in the El Paso County Community Health Improvement Plan, with priority areas being healthy eating and active living and mental health and substance abuse, all filtered through a lens of health equity. Their vision is to increase life expectancy for all in El Paso County by removing barriers that prevent people from achieving optimal health. The HCC consists of over 60 representatives from a multitude of organizations, such as schools, health systems (including behavioral health), a federally qualified health center, non-profit organizations, city and county government agencies, public health, medical providers, community foundations, grant making organizations and interested citizens. HCC meetings are held at least quarterly at the county's Citizens Service Center or a partner's community space.

I am pleased to confirm that **EPCPH, on behalf of the HCC**, has reviewed the Community Health Neighborhood Engagement action plan provided by **UCHealth Memorial Hospital Central, UCHealth Memorial Hospital North, UCHealth Grandview Hospital, and UCHealth Pikes Peak Regional Hospital** and intends to work with the hospital system during its pre-waiver Community Health Neighborhood Engagement process as it plans for its participation in the Hospital Transformation Program. 
